- Occupation-Based Leaders: Finding Our Way Forward
 - Have you ever been told that being a follower is not okay? This keynote will break down this assumption and discuss how we need followers to move outcomes forward.

- Discharge Planning Following Acute Hospitalization: “Is This Patient Really Safe to Discharge Home?”
 - The discharge planning process following acute hospitalization is complicated, multifactorial, and unique to each patient scenario. Occupational and physical therapy practitioners often rely on SNFs as a “safety net” for patients with difficult discharge situations. But what defines a “safe” discharge? This presentation will inform participants of current research, challenge historical discharge beliefs regarding discharge dispositions, and invite participants to think critically about our role in facilitating discharge following acute hospitalization. We aim to empower practitioners to make evidence-based decisions and provide practical solutions for complex situations and discussions that may arise in the discharge planning process.

- OT's Role in the ICU for Delirium Management: A Clinical Pathway for Implementation
 - Have you ever thought... "as OT practitioners we struggle to be fully understood and utilized in the acute care and ICU environment"? Look no further! This session will cover how we, as OT practitioners, can live up to our potential in acute care by improving our advocacy skills and utilizing scientific evidence in clinical practice. We will dive deep into a case study where an evidence-based delirium clinical pathway was implemented in the CVICU at the Cleveland Clinic. We will discuss how OT collaborated with other professions, how the clinical pathway was developed, and how the patient benefited distinctly from OT.
- Assessment of Sensory Integration & Processing Across the Lifespan (SPM-2 Review)
 - Sensory processing and integration assessments continue to be developed in efforts to support practitioners as they assess for concerns. Whether assessing in-person or virtually, there are assessment options available to identify challenges and support individuals from infancy through adulthood. Attendees of this session will come away with an understanding of how to assess sensory processing and integration challenges across the lifespan using observations and rating scales, as well as make appropriate recommendations to address identified concerns.

- Building Capacity and Infrastructure for Sustainable Interprofessional Education and Interprofessional Collaboration
 - Healthcare professionals interact and have several interprofessional touchpoints throughout the day depending on the clinical setting. Conversely, in the academic setting, healthcare education continues to be siloed having very few structured or organic interprofessional touchpoints. Recently, there has been a call to further embrace IPE not only at the educational level but to further consider IPE supporting the people within the structure of the healthcare system. Quality improvement methodology utilized in this study provided the structure to improve not only consistency across programs in the interdisciplinary team's college but also enriched the student's clinical experience.
- Letting Kids be Kids Even with an SCI
 - Over 8% of all spinal cord injuries (SCI) occur in pediatrics. Children with SCI have a greater duration of long-term complication risks due to their age, as well as additional developmental considerations compared to adult populations. In order to best address the needs of our SCI patients, our inpatient OT and PT teams completed a structured literature review for best practice across the care continuum. In this course we will review our literature findings, clinical recommendations, as well as opportunities for objective measurement.
